


 VfC conducted a final progress meeting on Community Law launching with Jima, Dambex and Warawau community on the 12th December 2016.

In this edition, VfC is pleased to share with its partners and the people of Jiwaka updates about various activities it has carried out in the fourth quarter of the year.


VfC values its partners in combining efforts to address violence against women and girls in the communities and the province.

Mr Henry Kolts is from Tombil in Minj South Waghi district. He is a community leader from his Bereupka tribe and the Deputy Peace Chairman of South

Waghi.



In 2015, Mr Kolts received GBV/HR training. Since then, he joined VfC as a Women Human Rights Defender and a Peace Builder. He is attached with the GBV response and referral desk assisting and making referrals for survivors to seek police and court services.

This year 2016, he attended a one month International Leaders training in Fiji on Violence Against Women through VfC support program.

Mr Kolts is a women advocate who is/has participated in every activities relating to Ending Violence Against Women conducted by VfC and the partners.

He strongly consider the saying;

"The world will not be destroyed by those who do evil, BUT by those who watch them without doing anything".

Eradicating violence against women and building safer homes in his community is his dream.

He believes that giving the respect a woman deserve and allowing women to equally participate is the way forward for the development of the province.

He would like to see government support at district and village court levels to improve the court system on Women and Family laws so that perpetrators face the full force of the law.

Ms Maria Kaipek is from Jimbina community, Minj in South Waghi district. She is a mother of 7 children with the husband having more than one wife.



She has joined VfC as an Extension Worker in 2014 under the Oxfam Livelihood funded project.

Her extension work is on vegetable farming. She provides technical support in vegetable growing and marketing for women in her community.

So far, she have received piggery, fish and cooking trainings conducted by VfC.

Maria is also an active member of Voce for Change Savings Club. The savings club has helped her sustain her life through school fees and natural disasters like droughts.

This year 2016, she was again engaged by VfC as a Senior Extension Worker with a new Oxfam Harvest Project.

Her current role is to assist Didimeri from 8 selected communities in Jiwaka to do vegetable farming and marketing. These Didimeri are also called village extension workers.

From her experience as a mother looking after her children without any help from the husband, she strongly encourages women to work the land to generate income to sustain themselves.

Her dream is to see women to be self reliant and to grow and market vegetables for an alternate income.

Maria would like to see government support at community level to improve the living standard of the rural people especially women.

# **Peace Building and Social Mapping training**

A two weeks Peace Building and Social Mapping training was conducted by VfC on the 3rd to 14th of October 2016.

A total of **24** participants from Jiwaka

received the training with the theme: Peace and Security for Women and Girls; the way forward for development in Jiwaka.

The participants were peace mediators, community leaders, church leaders, police officers,

youth leaders and village court magistrates.

# **Livelihood Skills Trainings**

Under the Women Economic Empowerment Program (WEEP), 40 participants benefited from Piggery and Cooking trainings on the 23rd to 25th of November and 6th to 9th of December 2016 respectively.

The total participants were consist of 17 women and 8 men including youths.

The training was conducted for the Jimbina and Minj Station communities from South Waghi.

The training was conducted at the communities' requests aiming to help them learn new skills that they can use to earn alternate income to sustain themselves.

# Media Training in Goroka

A team from VfC attended a four days Communication and Media Training in Goroka from the 24th to 27th October 2016.

The training was organised by the Oxfam International for all its partners from within the country PNG.

It was to learn communication and media skills and knowledge applicable in the organisation's work.

# Initial planning meeting and training

# Women's Peace and Security Program

VfC has four programs and are; Ending Violence against Women/Girls, Young Women & Leadership, Women Economic Empowerment and Women's Peace and Security.

There are two sections under the Women's Peace and Security Program and are;

- Peace Building
- Community Consultation and Mobilisation

The program aims to cause peace and security in the communities in particular for women and girls. It is to liberate women and girls who have been imprisonment from cultural norms

The ultimate focus is to create a safe and free environment for women to be at peace and to participate equally in the development of the province.

Peace and security program has one staff directly overseeing and coordinating its sections and networks.

In 2013, there were 22 Women Human Rights Defenders that started with the project. However, there are total of 41 WHRDs from Jiwaka both men and women currently reporting to the Women's Peace and Security desk.

Voice for Change also have Peace Builders from Jiwaka working in collaboration with the project.

Community engagement is the main activity for the project through meetings, trainings and travelling into communities and doing follow-ups.

"Peace builders have NO boundaries and peace building is a way of living one's life"

Under this project, after two years of consultations with 3 communities from Jiwaka, Community Peace and Security Law was successfully launched on the 14th to 16th of December 2016.
